SECTION 4. FIRST AID MEASURES

SECTION 6. ACCIDENTAL RELEASE MEASURES

- **6.1 SPILL AND LEAK RESPONSE AND ENVIRONMENTAL PRECAUTIONS:** Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. Dispose of at an appropriate waste disposal facility according to current applicable laws and regulations and product characteristics at time of disposal (see Section 13 Disposal Considerations).
- **6.5 NOTIFICATION PROCEDURES:** In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations. SECTION 7. HANDLING AND STORAGE

- **7.1 PRECAUTIONS FOR SAFE HANDLING:** Isolate from oxidizers, heat, & open flame. Use only with adequate ventilation. Avoid or repeated breathing of vapor or spray mist. Do not get in eyes, on skin or clothing. Consult Safety Equipment Supplier. Wear goggles, face shield, gloves, apron & footwear impervious to material. Wash clothing before reuse. Avoid free fall of liquid. Ground containers when transferring. Do not flame cut, braze, or weld. Continue all label precautions! NEVER pour water into this substance. When dissolving or diluting, always add it slowly to the water.
- **7.2 CONDITIONS FOR SAFE STORAGE, INCLUDING ANY INCOMPATIBILITIES:** Keep separated from strong oxidants, strong acids, metals, food & feedstuffs. Keep dry. Do not store above 49 C/120 F. Keep container tightly closed & upright when not in use to prevent leakage.
